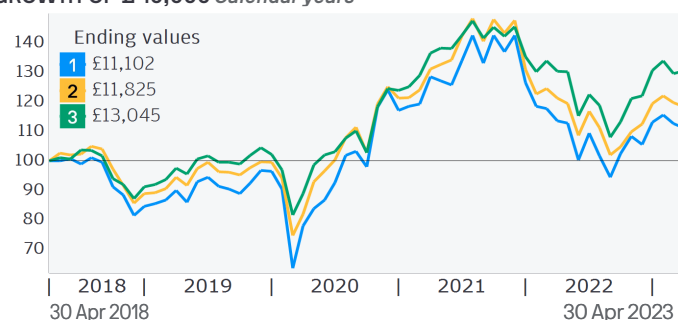

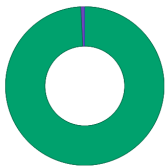

Definitions

Benchmark comparison Comparison of the Company's performance is made with the benchmark.
