## Manager commentary

The 'small company (small-cap) effect' identifies that over the longer term the return of individual company shares are typically inversely related to their size. But during 2023, return has been dominated by the appreciation of the largest companies known as mega-caps. The seven technology mega-caps in the US for example, have on average more than doubled over 2023. Meanwhile, UK small-caps listed on the Alternative Investment Market (AIM exchange) on average fell modestly.

During the final quarter of 2023, the companies whose share prices rose started to include the medium (mid) sized companies. Bond prices also improved markedly as investors anticipated interest rate cuts in 2024.

At this stage however, the small-cap trend hasn't worked all the way down into UK-quoted genuine small and micro-caps. The final quarter may have been the best of the four for companies listed on the AIM exchange, but often the share price increases only made up for when these had been weak earlier

If anything, economic conditions are changing from the period of globalisation. With interest rates above inflation for example, global growth often suffers a pronounced setback. At such times, large companies with their major market positions can really struggle, as the large can't easily make up for a demand shortfall by expanding rapidly enough in other areas. In contrast, small-caps, with their greater agility, can sometimes make up for a setback by expanding elsewhere.

Thus, if the current economic and geopolitical trends continue, they favour the UK stock market because it is dominated by cash generative companies that tend to be somewhat resilient when financial conditions are tough. During the persistent inflationary pressures and recessions between 1965 and 1985 for example, we note that the UK stock market greatly outperformed the US stock market. Alongside, the best performing part of one of the best performing global stock markets were UK micro-



The ongoing charges figure (OCF) is not the same as the ongoing costs figure set out in the Company's Key Information Document.

The key differences are that gearing costs and portfolio transaction costs are not included in the OCF. In addition costs are calculated on slightly different bases. The OCF figure set out above mirrors that in the Report and Accounts and is based on costs incurred in the year which are likely to recur in the foreseeable future. ## General risks

## Other risks

Some of the main specific risks of investing in this trust are summarised here.

## Derivative

A contract whose value is based on the change in price of a specific asset or index. When derivatives are used within a trust, it doesn't necessarily increase risk. However, price changes in the underlying asset can translate into big swings in the value of derivatives (up and down), which has a direct effect on the value of the trust.

## **Equities**

Equities (shares) can experience high levels of price fluctuation.

## Geographic concentration

Trusts that have a strong focus on a particular country or region can carry a higher risk than trusts with a more diversified portfolio.

## Hedging

A hedge is designed to offset the risk of another investment falling in price. It can also act as a limit on potential gains if the investment that has been hedged increases in value.

## Inflation

Higher inflation can lead to some investments falling in value, particularly those with a fixed level

of interest, for example government bonds and

## corporate bonds. Infrastructure

Investments are often in large-scale projects whose profitability can be affected by supply problems or rising prices for raw materials or natural resources. Changes in the wider economy and government regulation can also have a significant influence.

## Interest rate

Changes in central bank interest rates can affect all types of assets, in particular, securities such as government bonds and corporate bonds that generally offer a fixed level of interest. If interest rates go up, the value of a bond may fall, and vice versa.

## Legal and tax

The income or capital gains from investments can sometimes be affected by changes in legal and tax regulations or how these rules are applied.

## Liquidity

In some instances, for example, when market conditions generally are difficult, holdings in a trust may be difficult to sell and buy at the desired price. The trust value could fall as a result.

## Operational

Processes, systems and controls around your investment might fail. The more complex or unusual the investments that the trust holds, the more likely this is to happen. For example, developing markets may have less reliable systems or lower standards of governance than more developed markets.

## Property and Real Estate Investment Trusts

Property values can rise and fall sharply depending on the strength of a country's economy.

## Put-options

A type of derivative. Put-options can be used for a number of reasons. For example, they can be used to protect the value of an underlying investment or group of investments against a fall in value. They can be thought of as an insurance policy. These can make a trust more volatile from time to time.

## Smaller companies

Investment in smaller companies is typically higher risk than investment in larger companies. Shares in smaller companies can experience greater levels of volatility.

## Glossary

## Annual management charge (AMC)

The yearly fee paid to Premier Miton for managing a trust, expressed as a percentage of your investment. The AMC does not typically change from year to year.

#### Assets

Different groups of investments such as company shares, bonds, commodities or property.

## Bonds (or fixed income)

Types of investments that allow investors to loan money to governments and companies, usually in return for a regular fixed level of interest until the bond's maturity date, plus the return of the original value of the bond at the maturity date. The price of bonds will vary and the investment terms of bonds will also vary.

#### Capital

Describes financial assets, particularly cash, or other assets, such as shares, owned by a person or organisation.

## Capital growth

The increase in the value of an asset or investment over time, measured by its current value compared to its purchase cost

## Discount

The shares of investment trusts can have a price below the value of their net assets, this difference is known as the discount. The shares can also be at a premium to their net assets.

## Dividends

The portion of its capital that a company chooses to return to its shareholders. For a trust, this is the payment of trust's income to its shareholders.

## **Equities**

Another name for shares (or stock) in a company

## FTSE 100 Put Option

A type of derivative contract in which the underlying value is based on the level of the FTSE 100 index which tracks the performance of the top 100 largest companies by market value listed on the London Stock Exchange. Such contracts can be used to protect the value of an underlying investment or group of investments against a fall in the value of those 100 largest companies and can be thought of as an insurance policy.

## Gearing

The level of a company's debt in relation to its capital. A company with significant debt compared to its capital is considered to be highly geared.

## Individual Savings Account (ISA)

A type of tax-free scheme, set up by the government, designed to help people make the most of their savings and investments. All income and gains from an ISA investment are exempt from UK Income Tax and Capital Gains Tax, HM Revenue and Customs sets the maximum amounts that you are allowed to invest into an ISA each tax vear.

## Small-cap

On the London Stock Exchange, the term 'small cap' refers to companies with a market capitalisation between £50m and £230m.

#### Micro-Cap

A company with a market capitalisation (the total value of all a company's shares) of below £250 million

#### Net Asset Value (NAV)

The total of a company's assets minus its liabilities. The net asset value per share is the total of a company's assets minus its liabilities divided by the number of shares

## Ongoing Charges Figure (OCF)

As recommended by the Association of Investment Companies in its guidance, ongoing charges are the Company's annualised revenue and capital expenses (excluding finance costs and certain nonrecurring items) expressed as a percentage of the average monthly net assets of the Company during the year. Please note this figure is different to what is stated in the PRIIPS KID

## Total return

A way of showing how an investment has performed, and is made-up of the capital appreciation or depreciation and includes any income generated by the investment. Measured over a set period, it is expressed as a percentage of the value of the investment at the start of that period.

## Share price yield

The dividend per share divided by the stock's or fund's price per share and expressed as a percentage. The historic yield is the dividend income distributed during the past year and expressed as a percentage of the share price on a particular day.
